

Flushline Group Limited ("Flushline", "the Company") will pursue a policy aimed at minimising environmental damage and maximising opportunities for continual environmental improvement.

In all of our activities, we shall consider environmental impact at the planning stage. We shall maintain suitable standards of pollution control, conservation of energy and natural resources and the preservation and enhancement of natural habitats. Our company recognises the importance of protecting and preserving our natural environment and understands that we have a responsibility to prevent pollution.

To implement this policy, the company will ensure its site management and supervisors are aware of the environmental implications of activities within their own areas of responsibility and empowered to control our impacts. Where necessary, additional training may be required to heighten awareness of the relevant issues.

Statement

On individual contracts, Flushline Group Limited shall endeavour to obtain the best advice from our clients concerning the environmental aspects of the contract. In many cases, our client (often Principal Contractor) will already be maintaining ISO 14001 systems; we would actively support and implement these systems as instructed or where they are found to provide benefit. We will comply with all applicable environmental legislation along with any other requirements to which our company may subscribe.

During the execution of our works, we will manage and organise the works in a manner which will reduce, so far as is reasonably practicable, environmental impacts caused by:

- Noise, Odour, Dust Contamination
- Effluent and waste arising from the works
- Storage and transport of COSHH materials and other substances.

In simple terms, we aim to **Reduce** waste, **Re-use** materials where possible, and **Recycle** suitable materials. In many cases, we will offer alternatives to Client specifications if we feel the 3Rs are not being fully utilised. We will also take effective precautions to protect adjacent land, buildings and members of the public from any danger, discomfort or nuisance.

In pursuance of this policy, environmental considerations will be taken into account in the selection of materials and suppliers, which shall be from sustainable sources wherever reasonably practicable. All waste material will be disposed of appropriately, and all waste removal or transfer will be by licensed hauliers to properly manage and licensed tips. Copies of the relevant certification will be obtained for each contract.

To manage and improve our environmental impact, we will continue to set, monitor and review environmental objectives. These objectives will be regularly reviewed, audited and assessed by ourselves as well as by UKAS-accredited external assessors as we undertake ISO 14001 accreditation.

All FLUSHLINE personnel will be made aware of this policy and its contents, and we will work with them to proliferate and support the best environmental practices throughout our organisation.
